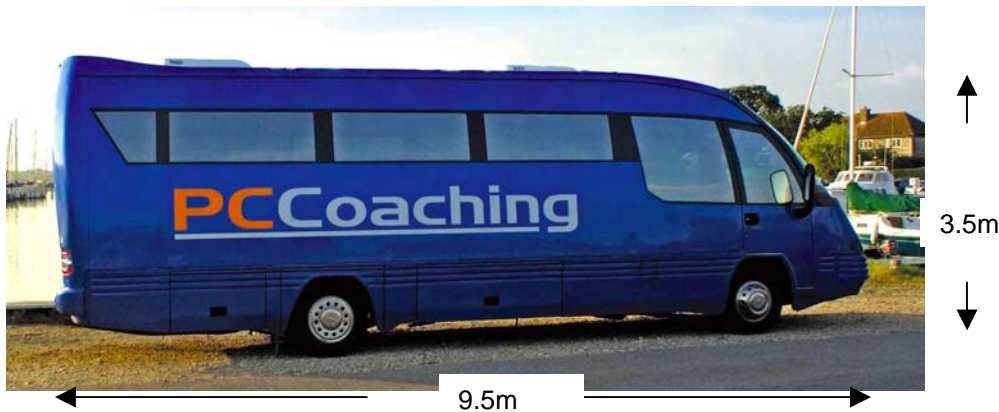

Power Requirement – Each Coach requires either a normal domestic 13amp socket or a 16amp 'caravan' style socket. Each coach carries 15m of power cable with toughened covers available so that it can be laid across paths or be run over by occasional traffic.

If power is unavailable an onboard generator can be used and is subject to an additional charge to cover fuel. It is advisable not to park the coach within 5m of an office when the generator is running.


